Regular Board Meeting
Tuesday November 27, 2018

Mayor Perkins called the meeting to order at 6:03 pm followed by the Pledge of Allegiance.

Roll Call: Present – Mayor Perkins, Trustee Murphy, Trustee Houghton, Trustee Chatterton and Evelyn M. Stelmashuck, Village Clerk.

Also Present: Kevin Dwyer, Treasurer(7:10); Rodney Perkins, Resident.

Absent: Trustee Zender

Meeting: Mayor Perkins said tonight's meeting was called to pay the November bills and take care of business that couldn't be done at the November 21 regular meeting as we didn't have quorum.

Mailbox: Mayor Perkins said that Supervisor Phillips said she wants a mailbox outside of the Clerk's office. Trustee Murphy found one on the Internet for \$26.08. Trustee Houghton made a motion for the Village to buy a mailbox for Supervisor Phillips which was seconded by Trustee Chatterton, all in favor, motion carried.

Ash Borer: Trustee Chatterton spoke on a seminar he went to about the Emerald Ash Borer. Neil said that National Grid would trim Ash trees that are on the roadways.

Street Lights: Mayor Perkins contacted Dave Hess from National Grid and they will put up 3 new Street Lights on poles #15, #17 and #19. He will also make sure all our Street Lights are at 25 watts. Trustee Houghton made a motion to allow National Grid to put up the new Street Lights and make sure all our lights were on 25 watts which was seconded by Trustee Chatterton, all in favor, motion carried.

Welcome Letter: Mayor Perkins passed out copies of Welcome Letters with General Information that she sent to new residents.

Trustee Houghton motioned to pay the T & A fund vouchers numbers 44-56 in the amount of \$2,087.30, which Trustee Chatterton seconded, all in favor, motion carried.

Key Bank Payment: Trustee Houghton motioned to have Treasurer Dwyer pay the Key Bank payment, which was seconded by Trustee Murphy, all in favor, motion carried.

Delinquent Tax List: Trustee Murphy motioned to certify the delinquent tax list, which was seconded by Trustee Houghton, all in favor, motion carried.
