**Communications:** The bid for the village lawn care maintenance from Kangaroo was presented to the board. There was a discussion about ConnextCare closing in Parish. There was a discussion about the villages website having incorporate a .gov website.

**Sewer Plant Report:** Tom Ballard indicated that there were no violations in March. Ken Sherrieble wants to do a RFQ for the Waste Water Treatment plant for us with the help from Tug Hill representatives. He also wants to hold a special meeting next week to discuss the items. There was a quote from Tom for pump station repairs which Trustee Youngman made a motion to accept the quote, which was seconded by Trustee Eldred. All In Favor...Carried.. Trustee Brown made a motion to accept the sewer report, which was seconded by Trustee Youngman. All In Favor...Carried.

**Building Inspector/Code Enforcement Officer Report:** No Codes report was presented

**Tug Hill Report:** There were numerous items brought up that are in the Tug Hill Times report. There was a mention that there is a USDA secretarial disaster designation to help farmers in Oneida, Lewis, Herkimer and Madison counties with building collapses from the February storms which hasn't been approved yet. There is also a new municipal requirements requiring municipalities to incorporate a .gov domain. Municipal parks and recreational grant due May 2<sup>nd</sup>. Tug Hill also has a new FaceBook page and website that are available online. The next salmon rivers meeting will be June 25<sup>th</sup> at 6:30 PM, the location has not been made yet. Joint meeting and Dinner with North Shore Council of Governments possibly at the North Riding barn in Cleveland. There are two spots open, one for Mayor Jackie and the second was requested by Trustee Eldred. The InterMunicipal Agreement needs to be signed in the next board meeting. **Old Business:** Trustee Eldred made a request to post the village election results on the village website. There was a discussion regarding the village keys distribution. Trustee Brown also made a request to get the no parking sign in front of his house fixed.

**New Business:** The APW drama club presented a request to utilize the village roads and parks for a 5K walk/run on May 31<sup>st</sup>. Trustee Youngman Brown made a motion to accept the 5K walk/run request, which was seconded by Trustee Eldred. All In Favor...Carried. There was a discussion regarding the bid for the panic buttons from Volney Multipplex as Priority Connections has indicated they are out of business as of 5/31/2025. They stated that the services will continue until December 31<sup>st</sup> 2025 however the buttons were tested prior to 5/31/2025 and they proved to not alert the company Centra-larm that handles the alerts when they happen.Trustee Youngman Brown made a motion to accept the Volney Multiplex Panic Buttons along with motion sensors and window alerts, which was seconded by Trustee Brown.
